The online pre-bidding conference for the SUPPLY AND DELIVERY OF ICT EQUIPMENT AND SOFTWARE (DA-BAFE PROJECT) via Cisco Webex was called to order at 1:30pm of March 30, 2021, and was presided by the BAC Chair, Dr. David L. Cero. The Chair acknowledged the presence of the prospective bidders thru video-conferencing.

The Chair introduced the BAC Members, members of the Technical Working Group, members of the BAC Secretariat and no observers attended the online pre-bidding conference. Six prospective bidders attended the online pre-bidding conference via Cisco Webex; Joneco Tech. Marketing Corp., DCI Intl. IT Solutions & Services Corp., Masangkay Computer Center, Maximum Solutions, epldt, and American Technologies, Inc.

The Chair emphasized and clarified the following:

- ABC of the project is One Million Four Hundred Ten Thousand Pesos only (₱ 1,410,000.00).
- The minimum specifications were discussed, and higher specifications are accepted.
Changes were the following:
 - a. Item No. 1 - (10 units Laptop)
 - Display is 15.6 inches
 - DDR4 RAM is 32GB
 - Bluetooth 5.0
 - b. Item No. 2 - (2 Units Laptop)
 - Display is 15.6 inches
 - Bluetooth 5.0
 - c. Item No. 3 - 12 Units of Microsoft Office 2019 Professional Plus
 - d. Item No. 5 - 12 Units of Windows 10 OS Professional OEM
- One (1) Lot bid all, price for each item may exceed in each ABC but not the total ABC.
- Warranty is 1 year
- Delivery period is 30 days.


Other Matters:

1. The BAC is still requesting prospective bidders to submit three (3) sets of bidding documents for simultaneous opening and evaluation of the BAC members and TWG. Preferably with tabs.
2. Payment of bidding documents is required before submission. Deadline of bid submission is on **April 14, 2021; 12:00noon**, late bids will not be accepted.
3. Bid opening will be face to face, to be held on **April 14, 2021 at 1:30pm** at International House 2, CvSU, Indang, Cavite.
4. Changes in the schedule will be communicated and the BAC will issue bid bulletin for the purpose.
5. Bid submission through Courier system is also allowed. However, the bid documents must be received by the BAC before the deadline of submission of bids.
6. For those who are interested to attend the face to face bid opening, prospective bidders are advised to send one (1) representative only per company. The University is implementing a health protocol to observe; that is, to wear face mask and face shield and to present a valid health certificate from Barangay or Rural Health Unit.


There being no other matters to be discussed, the pre-bid conference was adjourned at 1:50 pm.
