

INVITATION TO APPLY FOR ELIGIBILITY AND TO BID

Prospective bidders should have experience in undertaking a similar project within the last two (2) years with an amount of at least 50% of the proposed project for bidding. The Eligibility Check/Screening as well as the Preliminary Examination of Bids shall use non-discretionary "pass/fail" criteria. Post-qualification of the lowest calculated bid shall be conducted.

All particulars relative to Eligibility Statement and Screening, Bid Security, Performance Security, Pre-Bidding Conference(s), Evaluation of Bids, Post-Qualification and Award of Contract shall be governed by the pertinent provisions of R.A. 9184 and its Implementing Rules and Regulation (IRR).

Bid Documents will be available to prospective bidders. It may be downloaded free of charge from the website of the Philippine Government Electronic Procurement System (PhilGEPS) and the Cavite State University website. Interested bidders shall pay a non-refundable amount of **Five Thousand Pesos only (₱ 5,000.00) to the CAVITE STATE UNIVERSITY Cashier** not later than the submission of bids not later than the submission of bids.

Pre-Bidding conference shall be open to all interested bidders. Bids must be delivered to the Office of the BAC Chairman, Administration Bldg., CvSU, Indang, Cavite on or before the abovementioned date and time. All bids must be accompanied by a bid security in any of the acceptable forms and amount. Bids will be opened in the presence of the bidders' authorized representatives who choose to attend the bidding. Late bids shall not be accepted.
