

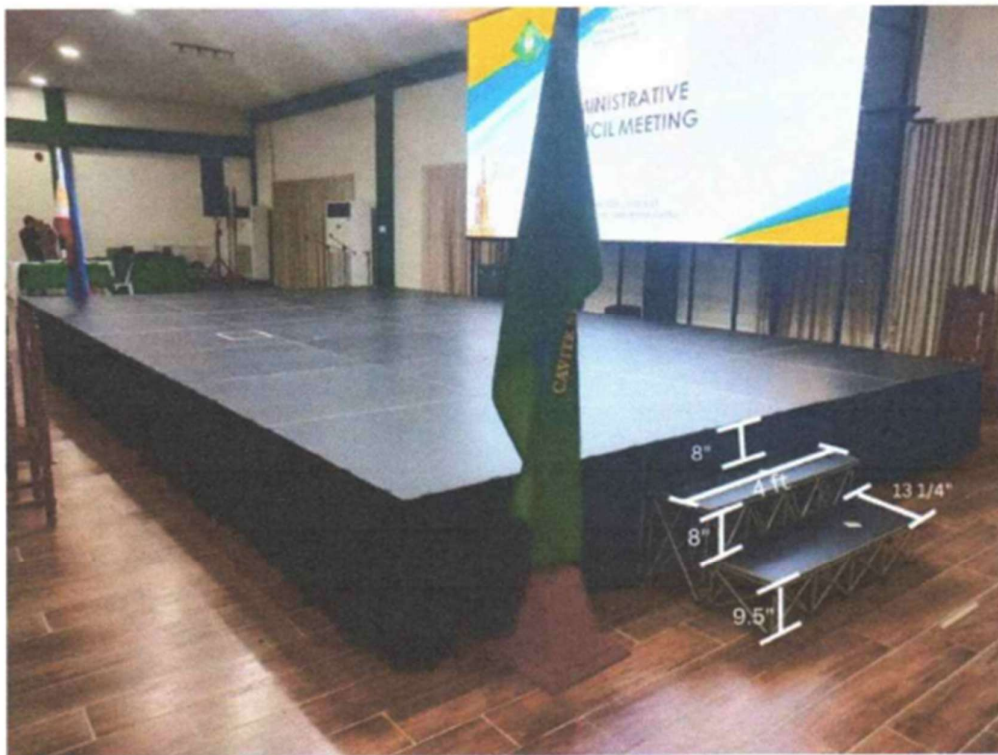

$$\begin{aligned} A1 &= 4.88\text{m} \times 8.53\text{m} \\ &= 41.66 \text{ m}^2 \end{aligned}$$

$$\begin{aligned} A2 &= 8.53\text{m} \times 0.65\text{m} \\ &= 5.53 \text{ m}^2 \end{aligned}$$

$$\begin{aligned} A3 &= 4.88\text{m} \times 0.65\text{m} \\ &= 3.16 \text{ m}^2 \end{aligned}$$

$$\begin{aligned} A4 &= A3 \\ &= 3.16 \text{ m}^2 \end{aligned}$$
