SCOPE OF WORK:

REPAINTING OF ROOFING SHEETS OF MULTI-PURPOSE BUILDING (ICON BLDG.) A. GENERAL DESCRIPTION

- 1. The project should be finished for 60 calendar days.
- 2. Actual site inspection is a must
- This set of specifications shall govern the methods of construction and the kinds of materials to be used for the proposed project shown in the plans and detailed drawings.
- 4. The plans, detailed drawings and these specifications shall be considered as complementing each other, so that what is mentioned or shown in one, although not mentioned or shown in the other, shall be considered as appearing on both. In case of conflict between the two, the same should be referred to the project inspector for resolution.
- All parts of the construction shall be finished with first class workmanship, to the fullest talent and meaning of the plans and these specifications, and to the entire satisfaction of the project inspector and the end-user.

B. TECHNICAL DESCRIPTION

- I. Painting Works
- This work includes the painting of the whole roofing component.
 Apply red oxide primer by brush or spay. Allow to dry for 24hours. Apply suitable putty on imperfections.
- 3. Apply at least two coats of Quick Dry Enamel in the desired color.

NOTE: Color or paint will depend upon the preference of the end-user. Paints and its accessories should be BOYSEN or approved equal.
