I. Objectives:

- To provide structural analysis and design
- To provide structural plan and specifications based on the results of analysis
- To conduct site inspection during the construction period

Site Inspection during Construction	During construction period	Site inspection at least once a month and as needed.


III. Minimum Qualifications
