Brief Description : The project involves earthworks, concrete works, masonry works, tile works, carpentry works, rafters & roofing works, miscellaneous works, electrical works, fire protection works, plumbing works, painting works.

Contract Duration : **210 CALENDAR DAYS**

Approved Budget for the Contract : **₱ 14,000,000.00**

Bids received in excess of the ABC shall be automatically rejected at bid opening.
