Bids received in excess of the ABC shall be automatically rejected at bid opening.

Bidding will be conducted through open competitive bidding procedures using non-discretionary "pass/fail" criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.

All particulars relative to Eligibility Statement and Screening, Bid Security, Performance Security, Pre-Bidding Conference(s), Evaluation of Bids, Post-Qualification and Award of Contract shall be governed by the pertinent provisions of R.A. 9184 and its Implementing Rules and Regulations (IRR).



A complete set of Bidding Documents may be acquired by interested bidders on the abovementioned date and time from given address and website and upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of **Five Thousand Pesos Only (₱5,000.00) to the CAVITE STATE UNIVERSITY Cashier** not later than the submission of bids.

Pre-bid conference shall be open to prospective bidders. Bids must be duly received by the BAC Secretariat through **manual submission** at the **Procurement Office, Administration Bldg., Cavite State University, Indang, Cavite** on or before the abovementioned date and time. All bids must be accompanied by a bid security in any of the acceptable forms and amount. Bids will be opened in the presence of the bidders who choose to attend the activity.
