Brief Description : The project involves mobilization, earthworks, sub-grade preparation, concrete pavement, form and painting works, and miscellaneous works.
Contract Duration : **45 CALENDAR DAYS**
Approved Budget for the Contract : **₱ 1,010,278.50**

Bids received in excess of the ABC shall be automatically rejected at bid opening.

Bidders should have completed a contract similar to the project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II (Instructions to Bidders).

Bidding will be conducted through open competitive bidding procedures using non-discretionary "pass/fail" criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.

All particulars relative to Eligibility Statement and Screening, Bid Security, Performance Security, Pre-Bidding Conference(s), Evaluation of Bids, Post-Qualification and Award of Contract shall be governed by the pertinent provisions of R.A. 9184 and its Implementing Rules and Regulations (IRR).

All bids must be accompanied by a bid security in any of the acceptable forms and amount. Bids will be opened in the presence of the bidders who choose to attend the activity.
