Brief Description : The project involves construction of bicycle zipline structure, and construction of two units pavilion.

Contract Duration : **180 CALENDAR DAYS**

Approved Budget for the Contract : **₱ 1,660,492.15**

Bids received in excess of the ABC shall be automatically rejected at bid opening.

Bidding will be conducted through open competitive bidding procedures using non-discretionary “pass/fail” criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.

All bids must be accompanied by a bid security in any of the acceptable forms and amount. Bids will be opened in the presence of the bidders who choose to attend the activity.
