Brief Description : The project involves earthworks, concrete works, masonry works, tile works, carpentry works, trusses & roofing works, miscellaneous works, electrical works, plumbing works, fire protection works, and painting works.

Contract Duration : **240 CALENDAR DAYS**

Approved Budget for the Contract : **₱ 50,000,000.00**

Bids received in excess of the ABC shall be automatically rejected at bid opening.
