SCOPE OF WORKS:

REPAIR OF MULTI-PURPOSE BUILDING
A. GENERAL DESCRIPTION

- 1. The project should be finished for 60 calendar days.
- 2. Actual site inspection is a must.
- 3. The area should be cleared / cleaned before and after the construction work. Unusable used formworks, excessive soil fill and all other unwanted debris of construction works should be disposed properly.

B. TECHNICAL DESCRIPTION

I. Demolition & Excavation Works

- 1. Site preparation/ temporary enclosure/ mobilization/demobilization/office.
- 2. Demolition of wall on Grid H Grid 5-9.
- 3. Excavation of wall footing until tie beam (Approximately 1 meter from floor line)
- 4. Excavation should at least be 0.5 meter of wall from both sides.
- 5. Existing windows, doors and other components of the building must be handled carefully.

II. Masonry Works

- 1. Supply and Installation of CHB reinforced with 10mm deformed bar space at 0.60 m on center every 3 layers.
 - a. CHB 5" for the perimeter walls.
- Masonry works should be plastered plain cement.
- 3. Existing windows, doors & other components should be reinstalled properly.
- 4. Repair and reinstallation of demolished tiles along Grid H Grid 5-9.

III. Painting Works

- 1. This work includes the painting of the interior and exterior concrete/masonry component of the part of the multipurpose hall to be repaired.
- 2. Repair minor surface imperfections with skim coat. Let dry, sand then, spot coat with top coat color.
- 3. Apply two coats of colored factory mixed dirt resisting semi-gloss latex.

NOTE: Color of paint will depend upon the preference of the end-user. Paints and its accessories should be BOYSEN or approved equal.
